1. The brief particulars of the Composite Scheme of Arrangement are as mentioned below:

- a) The Composite Scheme of Arrangement filed by the Company was approved by Hon'ble NCLT, Mumbai Bench vide its order dated October 22, 2024.
- b) Appointed Date: April 1, 2023
- c) Effective date: April 1, 2025
- d) Date of Allotment: May 12, 2025
- e) The Composite Scheme of Arrangement inter-alia provides for the following:
 - i) Demerger of "Education Undertaking" of CP Capital Limited (formerly known as Career Point Limited) (CPL) and vesting the same into Career Point Edutech Limited (CPEL), an unlisted wholly owned subsidiary of CPL.

"In consideration of demerger of "Education Division" of CPL into CPEL, CPEL will issue 1,81,92,939 Equity Shares of Rs. 10/- each to the shareholders of CPL in the ratio of 1:1."

Prior to the Scheme, the paid-up Equity Capital of Career Point Edutech Limited was Rs. 61,29,470/- consisting of 6,12,947 equity shares of Face Value of Rs. 10/- each and the same were cancelled pursuant to the Scheme.

The issued, subscribed and paid-up equity capital of Career Point Edutech Limited post Arrangement is Rs. 18,19,29,390/- consisting of 1,81,92,939 equity shares of face Value of Rs. 10/- each fully paid.

2. As per Exchange Notice No. 20250507-6 dated May 07, 2025, CP Capital Limited (Formerly known as Career Point Ltd) had fixed Record date as May 09, 2025, for giving effect to the Scheme of Arrangement.
